The Board will reconvene as the State Board of Elections to consider: preparations for the February 2, 2010 General Primary Election including a report on the candidate petition filing period; dates for a possible December special Board meeting; consideration of Sequoia and AccuVote voting system modifications; status of the under-vote feature; updates on Alexander County, BEREP, legislation, IVRS, and Lump-Sum; campaign disclosure related complaints, civil penalty payments, hearings and appeals; potential ballot forfeiture for 2010; and a request for an Attorney General Opinion on Acceptance of Resolutions to Fill Vacancies in Judicial Nominations.

The Board may address other matters as needed and/or recess into executive session to consider litigation and/or personnel matters.
