


Illinois Representative District 104

Representative District 104

(Partially within Champaign and Vermilion Counties)

Representative District 104 shall include that part of Illinois beginning at the intersection of County Road 1200 E and County Rd 3200 N in Champaign County (Champaign County),
thence east along County Road 3200 N to Harwood Twp,
thence north along the Harwood / Ludlow Twp border to the Ford County border,
thence east along the Ford / Champaign County border to the Vermilion County border,
thence south along the Vermilion / Champaign County border to the northwest corner of Pilot Twp in Vermilion County,
thence east and south along the Pilot / Middlefork Twp border and the Pilot / Blount Twp border to 900 E,
thence south along 900 E to 2500 N,
thence east along 2500 N to 900 E,
thence south along 900 E to Gimlet Branch Creek,
thence generally east along Gimlet Branch Creek to the Blount Twp border,
thence south and east along the Blount / Pilot Twp border and continuing east along the north borders of Sections 17, 16, 15, 14 and 13 of T20N, R12W (2nd principal meridian), and continuing east along the north border of Section 18, T20N, R11W (2nd principal meridian) to the Blount Twp border,
thence north along the Blount / Newell Twp border for approximately 300 feet to the North Fork Vermilion River,
thence east along the North Fork Vermilion River for approximately 700 feet,
thence east for approximately 450 feet to the east border of Section 7, T20N, R11W (2nd principal meridian),
thence south along the east border of Section 7, T20N, R11W (2nd principal meridian) to W. Newell Rd,
thence east along W. Newell Rd (2300 N) to 1800 E,
thence south along 1800 E to 2100 N,
thence east along 2100 N to the Kankakee, Beaverville & Southern rail line,
thence north along the Kankakee, Beaverville & Southern rail line to Poland Rd,
thence east along Poland Rd to 1970 E,
thence south along 1970 E to the Norfolk Southern rail line,
thence northeast along the Norfolk Southern rail line to Poland Rd,
thence east along Poland Rd to the Indiana border,
thence south along the Illinois / Indiana border to Edgar County border,
thence west, southeast, and west, north and west along the Edgar / Vermilion County border to the southeast corner of Sidell Twp,
thence north along the Sidell / Carroll Twp border to the northeast corner of Sidell Twp,
thence west along the Sidell / Jamaica Twp border to 680 E,
thence north along 680 E to the Vance Twp border,
thence east along the Vance / Jamaica Twp border to the Catlin Twp border,
thence north along the Catlin / Vance Twp border to Salt Fork,
thence continuing north for approximately 1000 feet to 1500 Rd N,
thence west along 1500 Rd N (extended) to the Oakwood / Vance Twp border,
thence continuing west along the Oakwood / Vance Twp border to the Champaign County border,
thence north along the Champaign / Vermilion County border to County Road 1800 N,
thence west along County Road 1800 N to County Road 2350 E,

thence south along County Road 2350 E to County Road 1800 N,
thence west along County Road 1800 N to County Road 2275 E,
thence continuing west along the St Joseph / Stanton Twp border to the Urbana Twp border,
thence south along the Urbana / St Joseph Twp border to County Road 1250 N,
thence west along County Road 1250 N to S. Cottonwood Rd,
thence south along S. Cottonwood Rd to County Road 1200 N,
thence west along County Road 1200 N to S. Philo Rd,
thence north along S. Philo Rd to E. Curtis Rd,
thence west along E. Curtis Rd to the northwest corner of E ½ Section 31, T19N, R9E (3rd principal meridian),
thence south along the west border of E ½ Section 31, T19N, R9E (3rd principal meridian) to County Road 1200 N,
thence west along County Road 1200 N to E. Church St,
thence continuing west along W. Church St to W. Old Church Rd,
thence continuing west along W. Old Church Rd to County Road 900 E,
thence north along County Road 900 E to S. Duncan Rd,
thence continuing north along S. Duncan Rd to the Champaign City Twp border,
thence west along the Champaign City / Champaign Twp border to I-57,
thence north along I-57 to W. Kirby Av,
thence east along W. Kirby Av to Crescent Dr,
thence south along Crescent Dr to Phinney Branch,
thence southeast along Phinney Branch to Broadmoor Dr (extended),
thence east along Broadmoor Dr (extended) and continuing east and south along Broadmoor Dr to Galen Dr,
thence south along Galen Dr to Windsor Rd,
thence east along Windsor Rd to the Urbana Twp border,
thence north along the Urbana / Champaign City Twp border to a point approximately 50 feet south of W. Hazelwood Dr,
thence east for approximately 880 feet to S. 4th St,
thence north along S. 4th St to St. Marys Rd,
thence west along St Marys Rd to S. 1st St,
thence north along S. 1st St to the Champaign City Twp border,
thence east along the Champaign City / Urbana Twp border to Cunningham Twp,
thence south along the Cunningham / Champaign City Twp border to the Urbana Twp border,
thence east, south, east, south, east and north along the Cunningham / Urbana Twp border to E. Windsor Rd,
thence east along E. Windsor Rd to S. Anderson St (extended),
thence north along S. Anderson St (extended) and continuing north along S. Anderson St to E. McHenry St,
thence east along E. McHenry St to S. Philo Rd,
thence north along S. Philo Rd for approximately 500 feet,
thence east for approximately 2640 feet to the west border of Section 22, T19N, R9E (3rd principal meridian),
thence north along the west border of Section 22, T19N, R9E (3rd principal meridian) to the north border of Section 22, T19N, R9E (3rd principal meridian),
thence east along the north border of Section 22, T19N, R9E (3rd principal meridian) to the Urbana Twp border,
thence north along the Urbana /Cunningham Twp border to S. High Cross Rd,

thence north along S. High Cross Rd to N. High Cross Rd,
thence continuing north along N. High Cross Rd to IL 74,
thence west along IL 74 for approximately 110 feet,
thence north approximately 285 feet,
thence west approximately 285 feet,
thence northwest approximately 760 feet,
thence west approximately 750 feet,
thence north approximately 1200 feet to the Urbana Municipal border,
thence west approximately 1300 feet,
thence north approximately 275 feet to the Saline Branch Drainage Ditch,
thence southwest along Saline Branch Drainage Ditch to the Cunningham / Urbana Twp border
(approximately 500 feet east of Ward St extended),
thence north and east along the Cunningham / Urbana Twp border to Brownfield Rd,
thence northeast along Brownfield Rd to I-74,
thence northwest along I-74 to US 45,
thence northeast along US 45 to Airport Rd,
thence west along Airport Rd to the Somer/Urbana Twp border,
thence continuing west along the Somer / Urbana Twp border to the Cunningham Twp border,
thence south, east, south, east and south along the Cunningham / Urbana border to I-74,
thence west along I-74 to N. Market St,
thence north along N. Market St to Interstate Dr (extended),
thence west along Interstate Dr (extended) to the Hensley / Champaign City Twp border,
thence north, west, north, and west along the Hensley / Champaign City Twp border to I-57,
thence northeast along I-57 for approximately 1000 feet,
thence northwest for approximately 150 feet,
thence west approximately 2500 feet,
thence north approximately 1100 feet to the south border of Hensley Twp,
thence west approximately 1800 feet,
thence south approximately 970 feet,
thence southwest 200 feet,
thence northwest approximately 650 feet,
thence southwest approximately 120 feet,
thence southeast approximately 250 feet to Legacy Dr,
thence southwest along Legacy Dr for approximately 2200 feet,
thence east for approximately 1600 feet to I-74,
thence northwest along I-74 to N. Duncan Rd,
thence north along N. Duncan Rd to 2000 N,
thence east along 2000 N to the Somer Twp border,
thence north along the Somer / Hensley Twp border to the Condit Twp border,
thence east along the Condit / Somer Twp border to the Rantoul Twp border,
thence north along the Rantoul / Condit Twp border and continuing north along the East Bend / Ludlow
Twp border to the point of beginning.
