




Illinois Representative District 110



Representative District 110

(Encompasses the entirety of Clark, Coles, Crawford and Cumberland Counties, and partially within Edgar and Lawrence Counties):

Representative District 110 shall include that part of Illinois beginning at the northwest corner of Coles County, thence starting east along the Coles / Douglas County border to the Edgar County border, thence south along the Edgar County border to the southwest corner of Section 22, T14N, R14W (2nd principal meridian), thence east along the south borders of Sections 22 and 23, T14N, R14W (2nd principal meridian) to the southeast corner of Section 23, T14N, R14W (2nd principal meridian), thence north to 1220 N, thence southeast along 1220 N to the south border of Section 24, T14N, R14W (2nd principal meridian), thence south for approximately 1500 feet, thence west for approximately 1400 feet to the west border of Section 25, T14N, R14W (2nd principal meridian) (200E), thence south along 200 E to 1100N, thence east along 1100N to Hickory Grove creek, thence north along Hickory Grove creek to 1190N, thence east along 1190N to a point 1100 feet east of 550E, thence east for approximately 160 feet, thence north for approximately 730 feet, thence east for approximately 160 feet, thence north for approximately 220 feet to 1200 N, thence continuing east along County Road 300N to 1050E, thence south along 1050E and 1050E (extended), and continuing south along 1050E and 1050E (extended) to the Clark County border, thence starting east along the Edgar / Clark County border and continuing to the Illinois / Indiana border, thence generally south and west along the Illinois / Indiana border to the southeast corner Russell Twp in Lawrence County, thence west along the south border of Russell Twp to the southwest corner of Section 19, T4N, R10W (2nd principal meridian), thence north along the east border of Section 24, T4N, R10W (2nd principal meridian) to the northeast corner of Section 24, T4N, R11W (2nd principal meridian), thence west along the Russell / Allison Twp border to the northwest corner of Allison Twp, thence south along the west border of Allison Twp to 1260E, thence west along 1260E to 1400E, thence south along 1400E to 1030N, thence west along 1030N to 1340E, thence north along 1340E to 1040N, thence west along 1040N to 1330E, thence south along 1330E to 1030N, thence west along 1030N for approximately 1200 feet, thence west for approximately 1400 feet, thence south for approximately 1300 feet,

thence west for approximately 975 feet to Hickory St,
thence south for approximately 40 feet,
thence west for approximately 1500 feet to 8th St,
thence south for approximately 700 feet,
thence west for approximately 885 feet to approximately 40 feet east of 11th St,
thence south to Orchard St (extended),
thence west along Orchard St (extended) to Orchard St
thence continuing west along Orchard St and Orchard St (extended) back to Orchard St,
thence west approximately 600 feet along Orchard St,
thence north for approximately 850 feet,
thence west for approximately 360 feet,
thence northwest for approximately 2000 feet to Old Porter Rd,
thence southwest along Old Porter Rd for approximately 450 feet,
thence northwest for approximately 2175 feet,
thence northeast for approximately 1300 feet,
thence northwest for approximately 275 feet to US Rt 50,
thence southwest along US 50 to the border of Section 2, T3N, R12W (2nd principal meridian),
thence north along the east border of Section 2, T3N, R12W (2nd principal meridian) to US 50,
thence northeast along US 50 to 1100E,
thence north along 1100E for approximately 1650 feet,
thence west for approximately 180 feet,
thence north for approximately 125 feet,
thence east for approximately 180 feet to 1100E,
thence north along 1100E to the Embarras River,
thence northwest along the Embarras River for approximately 1500 feet,
thence north approximately 150 feet to 1020E,
thence northwest along 1020E and continuing north along 1020E to 1320N,
thence west along 1320N to the east border of Section 22, T4N, R12W (2nd principal meridian),
thence south along the east borders of Sections 22 & 27, T4N, R12W (2nd principal meridian) to the
Embarras River,
thence northwest along the Embarras River to the south border of Bond Twp,
thence west along the south border of Bond Twp to the Petty / Bond Twp border,
thence north along the Petty / Bond Twp border to the Crawford County border,
thence west along the south border of Crawford County to the Jasper County border,
thence north along the Jasper / Crawford County borders to the Clark County border,
thence west along the Clark / Jasper County borders, and continuing west along the Jasper /
Cumberland County borders, and continuing west along the Effingham / Cumberland County borders to
the southwest corner of Cumberland County,
thence north along the west borders of Cumberland, and continuing north along the west border of
Coles County to the point of beginning.
