


# Illinois Representative District 88

# Representative District 88

(Partially within Tazewell and McLean Counties)

Representative District 88 shall include that part of Illinois beginning at the northwest corner of Tazewell County (Tazewell County),

thence east, south, east and south along the Tazewell / Woodford County border to the McLean County border,

thence east along the McLean / Woodford County border to the northeast corner of Danvers Twp in McLean County,

thence south along the Danvers / White Oak Twp border to the northwest corner of Dry Grove Twp,

thence east along the Dry Grove / White Oak Twp border to the northeast corner of Dry Grove Twp,

thence south along the Dry Grove / Normal Twp border to the northeast corner of Section 25, T24N, R1E (3rd principal meridian),

thence continuing south along the east borders of Sections 25 and 36, T24N, R1E (3rd principal meridian) to a point approximately 130 feet north of the Bloomington City Twp border,

thence west for approximately 400 feet,

thence southeast for approximately 500 feet to the east Bloomington City Twp border,

thence east for approximately 2875 feet,

thence north for approximately 195 feet,

thence east for approximately 220 feet,

thence north for approximately 50 feet,

thence east for approximately 455 feet,

thence northeast for approximately 400 feet,

thence east for approximately 1595 feet,

thence southeast for approximately 310 feet to Martin Luther King Dr,

thence northeast and east along Martin Luther King Dr to Parkshores Dr,

thence south and east along Parkshores Dr to Cottage Av,

thence south along Cottage Av to a point approximately 100 feet north of the Bloomington City Twp border,

thence east and southeast for approximately 2360 feet to the intersection of Sherman St and W. Division St,

thence east northeast for approximately 480 feet,

thence south for approximately 100 feet to W. Division St,

thence east along W. Division St to N. Lee St,

thence south along N. Lee St to W. Kelsey St,

thence east along W. Kelsey St to N. Center St,

thence north along N. Center St to the Bloomington City Twp border,

thence east along the Bloomington City / Normal Twp border to Sugar Creek,

thence southeast approximately 700 feet to a point on Fell Av approximately 50 feet north of E. Kelsey St,

thence north along Fell Av to E. Division St,

thence east along E. Division St to S. Linden St,

thence south along S. Linden St for approximately 700 feet,

thence northwest for approximately 390 feet,

thence south for approximately 1100 feet to Marion St (extended),

thence east along Marion St (extended) and continuing east along Marion St to N. State St,

thence south along N. State St to E. Empire St,  
thence east along E. Empire St to N. Veterans Pky,  
thence south along N. Veterans Pky to E. Oakland Av,  
thence east along E. Oakland Av to S. Hershey Rd,  
thence south along S. Hershey Rd for approximately 2630 feet,  
thence east for approximately 540 feet,  
thence northeast for approximately 140 feet,  
thence east for approximately 580 feet,  
thence southeast for approximately 140 feet,  
thence east for approximately 2010 feet,  
thence south for approximately 2600 feet to Ireland Grove Rd,  
thence east along Ireland Grove Rd to N 1800 East Rd,  
thence south along N 1800 East Rd for approximately 2400 feet,  
thence west for approximately 55 feet,  
thence south for approximately 120 feet,  
thence east for approximately 50 feet,  
thence south along N 1800 East Rd for approximately 130 feet,  
thence west for approximately 50 feet,  
thence south for approximately 230 feet,  
thence east for approximately 50 feet to N 1800 East Rd,  
thence continuing south along N 1800 East Rd to Morrissey Dr,  
thence continuing south along the Old Town / Bloomington Twp border and continuing south along the  
Downs / Randolph Twp border to E 575 North Rd,  
thence west along E 575 North Rd to N 1750 East Rd,  
thence south along N 1750 East Rd to E 550 North Rd,  
thence west along E 550 North Rd to N 1625 East Rd,  
thence south along N 1625 East Rd to E 400 North Rd,  
thence west along E 400 North Rd ( the south border of Section 23, T22N, R2E (3rd principal meridian),  
thence west along the south borders of Sections 23 22, and ~~21~~, T22N, R2E (3rd principal meridian) to a  
point approximately 900 feet east of the southeast corner of Section 21, T22N, R2E (3rd principal  
meridian),  
thence north for approximately 1120 feet to E 425 North Rd,  
thence west along E 425 North Rd to N 1474 East Rd,  
thence north along N 1475 East Rd to E 450 North Rd,  
thence west along E 450 North Rd to N 1450 East Rd,  
thence north along N 1450 East Rd to E 525 North Rd,  
thence west along E 525 North Rd to N 1300 East Rd,  
thence north along N 1300 East Rd to E 700 North Rd,  
thence west along E 700 North Rd to the Funk's Grove Twp border,  
thence south along the Funk's Grove / Randolph Twp border to the southeast corner of Funk's Grove  
Twp,  
thence west along the Funk's Grove / Waynesville Twp border and continuing west along the Mount  
Hope / Atlanta Twp border to the Logan County border,  
thence north along the Logan / McLean County border and continuing north along the McLean /  
Tazewell County border to the northeast corner of Little Mackinaw Twp,  
thence west along the Little Mackinaw / Mackinaw Twp border to Sargent Slough creek,  
thence northeast along Sargent Slough to Mackinaw Rd,  
thence north along Mackinaw Rd to E. Hoffman Av,

thence south and west along E. Hoffman Av to Mount Joy Rd,  
thence south and northwest along Mount Joy Rd to N. Hoffman Av,  
thence continuing north, northeast , and north along N. Hoffman Av to Fast Av,  
thence northeast along Fast Av to the Mackinaw municipal border,  
thence north along the Mackinaw municipal border a point approximately 850 feet north of Fast Av,  
thence west for approximately 300 feet to the Mackinaw River,  
thence generally northwest along the Mackinaw River for approximately 1475 feet,  
thence northwest for approximately 3100 feet to the Tremont Twp border,  
thence south along the Tremont / Mackinaw Twp border for approximately 540 feet,  
thence northwest for approximately 13800 feet to the Morton Twp border,  
thence west along the Morton / Tremont Twp border and continuing west along the Elm Grove /  
Groveland Twp border to Country Club Dr,  
thence northwest along Country Club Dr and continuing west along Pekin Groveland Rd and Sheridan Rd  
to the Pekin Twp border,  
thence north along the Pekin / Groveland Twp border to the Coach Rd terminus,  
thence east along the north border of Section 19, T25N, R4W (3rd principal meridian) to the northeast  
corner of Section 19, T25N, R4W (3rd principal meridian),  
thence north along the east border of Section 18, T25N, R4W (3rd principal meridian) to Zion Oaks Rd,  
thence north and east along Zion Oaks Rd to Cole Hollow Rd,  
thence north along Cole Hollow Rd to W. Muller Rd,  
thence east along W. Muller Rd for approximately 1260 feet,  
thence north for approximately 1300 feet to I-474,  
thence east along I-474 to Pinecrest Dr,  
thence north along Pinecrest Dr for approximately 1540 feet,  
thence west for approximately 225 feet,  
thence south for approximately 145 feet to Allen St (extended),  
thence west along Allen St (extended) and continuing west along Allen St to Maria St,  
thence north along Maria St to its terminus,  
thence continuing north northeast for approximately 1680 feet to I-74,  
thence southeast along I-74 to Fahey Hollow Dr,  
thence north along Fahey Hollow Dr to Sabrina Ln,  
thence west and northwest along Sabrina Ln and Frontage Rd to Kerfoot St,  
thence north, west and north along Kerfoot St to a point approximately 120 feet south of the Fondulac  
Twp border,  
thence east for approximately 1100 feet to Fahey Hollow Rd,  
thence north along Fahey Hollow Rd for approximately 50 feet,  
thence east for approximately 2350 feet to the terminus of Stoneridge Ln,  
thence south along Stoneridge Ln for approximately 30 feet,  
thence west for approximately 160 feet,  
thence south for approximately 40 feet,  
thence east for approximately 80 feet,  
thence south for approximately 140 feet to Bloomington Rd,  
thence southeast along Bloomington Rd to a point approximately 400 feet west of Woodway Ct,  
thence north for approximately 1000 feet to the Fondulac Twp Border,  
thence east along the Fondulac / Groveland Twp border to Meadows Av,  
thence southeast along Meadows Av for approximately 550 feet,  
thence northeast for approximately 440 feet,  
thence southeast for approximately 240 feet to Oakwood Av,

thence northeast for approximately 260 feet to Joyce Ct,  
thence east for approximately 860 feet to Kenyir Av,  
thence east along Kenyir Av and continuing east along Kenvir St to its terminus,  
thence continuing east along the Fondulac / Groveland Twp border and continuing east along the  
Washington / Groveland Twp border, and continuing east along the Morton /WashingtonTwp border to  
the southeast corner of Section 31, T26N, R3W (3rd principal meridian),  
thence north along the east borders of Sections 31, 30 and 19, T26N, R3W (3rd principal meridian) to a  
point approximately 850 feet south of Centennial Dr,  
thence west for approximately 5280 feet to the Fondulac Twp border,  
thence south along the Fondulac / Washington Twp border to Washington St,  
thence southwest along Washington St to Harmony Av,  
thence north along Harmony Av to its terminus,  
thence north for approximately 135 feet,  
thence west for approximately 235 feet,  
thence north for approximately 535 feet,  
thence west for approximately 1000 feet,  
thence south for approximately 625 feet,  
thence west for approximately 2095 feet,  
thence north for approximately 5735 feet to Centennial Dr,  
thence west along Centennial Dr to Caterpillar Trail,  
thence south along Caterpillar Trail to Mariners Way,  
thence west along Mariners Way and continuing west along Mariners Way (extended ) to the Tazewell  
County border,  
thence north along the Tazewell / Peoria County border to the point of beginning.
